## Introduction

A decade has passed since the enactment of freedom of information ordinance (2002), the legal instrument granting citizens of Pakistan access to public records from the federal government departments. However, both the demand and the supply side mechanisms of information access still lay in an abysmal state.

This survey intends to highlight the perspectives of an assortment of citizens from the Federal Capital, Islamabad on the significance of Right to Information. Citizens from different corners of Islamabad were approached in streets, work places, markets, restaurants and parks and asked a single question: "What do you consider the significance of Right to Information to be?"

Most of the people, with a few exceptions from the scholarly circles, did not know of the legal mechanism available to access information from the government departments, therefore, before asking the question they were first briefly guided on the presence of access to information mechanism with the legal and constitutional cover available so they could be at a better position to provide an answer.



Raheem Bux PhD Scholar, QAU Access to information law is significant because It gives empowerment to society and ends the fears and confusions of the people by providing guidelines to individuals on how to obtain their rights. RTI creates a sense of ownership and responsibility among citizens. Moreover, it helps in catharsis.



Sehrish Ayaz Administrator, Public School It is important to have Right to Information as it plays an important role by allowing Citizens to know all the affairs of the government. RTI could assist in ensuring transparency and accountability in government.





If citizens are aware of RTI law, they can ask the concerned departments for annual allocated budget for construction of roads, streets, and sanitary system.




